If the adoptor chooses to return the animal to our shelter after the Fourteen (14) day return period, an owner surrender fee of One-Hundred Dollars (\$100.00) will be charged for the return.

\_\_\_\_\_ Adoptor understands that if the adopted animal is lost, stolen, or dies before the completion of the requirements of this agreement, adoptor will submit a letter explaining the details of the occurrence to the shelter including all related documents such as lost pet reports and veterinary documentation.

\_\_\_\_\_ Adoptor agrees to provide proper food, water, necessary veterinary care and expenses should this animal become sick or injured.

\_\_\_\_\_ Adoptor understands that this shelter does not guarantee the adopted animals Health, Behavior, Temperment, nor Training. Adoptor will not hold the shelter responsible for any illness, disease, or charges for treatment of this animal nor for any damages that this animal may cause to any person or property.
